HCCI and partners break ground on new Harlem affordable housing

The New York City Department of Housing Preservation and De-velopment (HPD), New York State Homes and Community Renewal (HCR), and the Community Preservation Corporation (CPC) joined L+M Development Part-ners, Harlem Congregations for Community Improvement (HCCI), and partners to announce the start of construction on 260 West 153rd Street in Manhattan.

The new seven-story develop-ment will include 50 units of affordable housing, an onsite daycare center, and new office space for HCCI. Also in atten-dance were U.S. Congressman Charles B. Rangel, New York State Assembly Members Herman D. Farrell and Keith L.T. Wright. Spearheaded by HCCI, this project represents an historic moment for the agency, which will realize its founders' vision for an HCCI headquarters dedicated to the revitalization of Harlem's Bradhurst community.

The construction of this new development is financed under Mayor Bill de Blasio's Housing New York: A Five-Borough, 10-Year Housing Plan, to create and preserve 200,000 units of affordable housing. The most compre-hensive affordable housing plan in the City's history and largest municipal housing plan in the nation, its goal is to help address New York City's affordability crisis by reaching more than half a million New Yorkers ranging from those with very low incomes to those in the middle class, all of whom face ever-rising rents.

When construction is complete, 260 West 153rd Street will include seven studio apartments, 30 one-will serve as an onsite bedroom apartments, and 13 two-

will serve as an onsite superintendent's unit. These

units will occupy approximately 52,215 square feet of residential space. This development will also feature approximately 14,331

square feet of community space, and 7,915 square feet for onsite parking. Apartments in this development

will be available to very low-income families. Of the total 50 units, 42 will be available to households earning a maximum of 50 percent of the Area Median Income (AMI), or an annual income of not more than \$29,400 for an individual and \$41,950 for a family of four. The remaining eight units will be available to households earning up to 30 percent AMI, or an an-nual income of not more than \$17,650 for an individual and \$25,150 for a family of four. Income levels are calculated annually by the U.S. Department of Housing and Urban Development, Income levels for this development are set by HUD's 2014 calculations.

calculations.

The total development cost for 260 West 153™ Street is approximately \$21.5 million. HCR will provide 9% Low Income Housing Tax Credits (LIHTC) toward permanent financing which will generate approximately \$13.8 million in tax credit seattly. Civil manifest accredits controlled to the controlled to the seattly. Civil manifest accredits controlled to the co equity. CPC will provide a perma-nent loan of \$5.1 million through the New York City Retirement Systems (NYCRS). HPD will provide \$1.09 million in City capital funding. Wells Fargo will act as the lender. This development will be constructed by L+M Builders. Curtis Ginsberg will act as the architect.

"50 new units might sound modest, but two thirds of the City's renter population lives in buildings like 260 West 153rd Street that consist of less than 50 units. The city's urgent housing crisis has stressed

Reports then surfaced that she and her son were in a car driven by her boyfriend when he was nulled over in 2011 for driving the wrong way on a one-way street in Edgewater, N.J. The officer reported smelling pot in the car, which belonged to Ms. Noerdlinger, and Mr. McFarlan was arrested for marijuana possession. Police in Edgewater said Ms. Noerdlinger was given a summons for allowing someone

to drive a car without a license.

Mayor Bill de Blasio said she was a hardworking public servant, and lamented what he called an over-focus on the pri-vate lives of public officials.

"Character assassination happens every day in public life," he said. "What's sad is when it goes beyond the boundary of public service ... We have to get on with the work and not be putting so much energy into one person's

The rank-and-file police union has called for Ms. Noerdlinger to

be fired. Their ire precedes her assisting Chirlane McCray: Ms. Noerdlinger used to be a top aide to the Rev. Al Sharpton, who has been a fervent critic of the NYPD for decades.

Mr. Sharpton said Monday he respected her decision and she has always put motherhood first. "I have watched her try to balance her very important and active professional life with her immovable commitment to her son, so I am not surprised with her decision," he

"I have told Rachel and Khari that we must reflect in life on how we combat unfairness and how we can better do things with ourselves to achieve our goals. "The IRS said that all of our employees other than those running outside consultant firms should have been employees and charged us payroll taxes, penalties and late charges. We brought in a new administrative team that corrected our employment practices and arranged an installment agreement to pay payroll taxes, penal-ties and late charges and have maintained to pay current taxes on time since 2008.

"They also arranged to negotiate my personal tax liens caused by my often deriving income in my name that went directly to National Action Network, that I therefor was charged for. They arranged for me to pay installments to settle those tax liens and pay all current taxes on a quarterly basis.

"Today, by correcting and liv-ing up to all of those arrangements we have been able to grow from 2007 being a local protest group with management issues, to a nationally respected group that grossed over five million dollars in 2013. We are now making the final payments on our installment agreement, both personally and organizationally that would remove those old liens (If we get the green light on the offer of compromise this will be done even more quickly).

"My point in sharing this with them is don't let outrageous smears deter you from your goals and don't be so defensive that you do not do what is necessary to move forward in life, to achieve what you are really committed to. I spoke with Mayor de Blasio and assured him that I will continue to work with him and the administra-tion on the political progressive

agenda we both agree on and will disagree with him when it becomes necessary

"I respect he and the First Lady's sensitivity to Rachel's parental concern. I in no way was part of Rachel being hired or maintaining her position with the First Lady as some have reported, but knowing her skills I know the tremendous contributions her talents give all New Yorkers."
